"REAL TIME" SPORTS CONTEST

Contest End Date: Sunday, December 31, 2017

RULES AND REGULATIONS

1. The sponsor of the contest is The New Meadowlands Racetrack, LLC ("Sponsor").
2. NO PURCHASE NECESSARY. The contest is free to enter. Contestants must be at least 21 years of age at date of entry and a legal resident of the United States or the District of Columbia.
3. Contestants must have a Meadowlands Player's Reward card to enter and complete the Meadowlands Sports Contest Form available at the Player's Reward Club desk. Contestants will be required to provide their driver license, social security number, name, address, e-mail address, and telephone number at the time of signup. Sponsor is not responsible for the accuracy of the information. Entry data will remain the property of Sponsor and will not be returned or acknowledged.
4. Each week, contestants will use their Meadowlands Player's Reward account number and the PIN created at registration in order to submit their picks. Entries are not transferable.
5. There is only one entry allowed per person. Holding more than one entry will result in disqualification from the contest.
6. Each Tuesday during the duration of the contest each player account will start with 1,000 points. After the Monday night game all accounts will be zeroed out and earned points will be posted to season totals.

7. In order to make picks, contestants will need to download the Victory Sports Bar mobile app available from PlayMeadowlands.com website, android or the iTunes app store. The app will guide contestants to enter account numbers and PINs in order to make picks.
8. All picks must be submitted at the Meadowlands facility through the MRE SPORTS WIFI.
9. The contest has a weekly prize and all players who qualify are eligible for a Grand Prize at the end of the contest.
10. Contestants must make at least one pick per week in order to be eligible for the weekly prizes. Contestants will have until 30 minutes prior to kick off to make their selections.
11. In the event of a cancelled game or a selection that results in no action, both sides of the pick will receive no points added to their account and the play amount will be added back into each contestant's point balance. The refund on a cancelled game will not be considered a play for the weekly prizes.
12. Picks entered cannot be changed or cancelled after the start time listed. If a contestant made an error in their selection, the contestant must go to the players club to cancel the selection. It is the sole responsibility of the contestant to provide and maintain their contestant number and PIN.
13. Sponsor is not responsible for lost, interrupted, unavailable, defective or damaged hardware, software, and electronic, wireless, or telephone transmissions or technical failures, garbled transmissions, and the unavailability of its website or any website associated with Sports Contests. Due to the unpredictable nature of present, state-of-the-art computer technology, server outages may occur resulting in your inability to participate, receive point updates and point credits in a timely fashion. We regret this unfortunate possibility. By agreeing to the terms and conditions herein, you fully recognize that the Sponsor is not responsible for such errors.
14. The odds of winning depend on the number of points accumulated by each participant each week. In the event of tie at the end of the week the \$2000.00 prize will be divided among the contestants who scored the most points.
15. Weekly winners will be notified by phone and e-mail and their names will be posted on the TV screen opposite the Player's Reward Club desk each Tuesday until the contest ends. The Grand Prize winner will be determined and notified by telephone and e-mail at the end of the contest.
16. PRIZES. 17 weekly prize winners will receive a \$2,000.00 betting voucher from the Sponsor. One Grand Prize winner will receive a \$10,000.00 betting voucher from the Sponsor. Weekly

winner will be selected by the contestant who accumulates the highest points for a week Tuesday through Monday. Grand prize will be chosen by the contestant who has the most accumulative weekly wins. In the event of a tie the grand prize will be chosen by highest total points scored by the contestant with the most weekly wins.
