



NMR "BASKETBALL CHALLENGE"

"REAL TIME" SPORTS CONTEST

Starting March 15, 2018

RULES AND REGULATIONS

The sponsor of the contest is The New Meadowlands Racetrack, LLC ("Sponsor").

1. NO PURCHASE NECESSARY. The contest is free to enter. Contestants must be at least 21 years of age at date of entry and a legal resident of the United States or the District of Columbia.
2. Contestants must have a Meadowlands Player's Reward card to enter and complete the Meadowlands Sports Contest Form available at the Player's Reward Club desk. Contestants will be required to provide their name, address, e-mail address, and telephone number at the time of signup. Sponsor is not responsible for the accuracy of the information. Entry data will remain the property of Sponsor and will not be returned or acknowledged.
3. Each week, contestants will use their Meadowlands Player's Reward account number and the PIN created at registration in order to submit their picks. Entries are not transferable.
4. There is only one entry allowed per person. Holding more than one entry will result in disqualification from the contest.
5. At the beginning of the NCAA tournament each customer who has signed up for the contest will receive 1,000 points into their account. At the conclusion of the tournament the player with the most points will be declared the winner. At anytime during the contest should a contestant have his point total go to zero they are eliminated from the tournament and cannot enter again.

6. In order to make picks, contestants will need to download the MRE Sports mobile app available from PlayMeadowlands.com website or the iTunes app store. The app will guide contestants to enter account numbers and PINs in order to make picks.
7. All picks must be submitted at the Meadowlands or at Winners Bayonne.
8. The contest has a weekly prize for each of the four weeks and all players who qualify are eligible for a Grand Prize at the end of the contest.
9. Contestants must make at least one pick per week in order to be eligible for the weekly prizes.
10. In the event of a cancelled game or a selection that results in no action, both sides of the pick will receive no points added to their account and the play amount will be added back into each contestant's point balance. The refund on a cancelled game will not be considered a play for the weekly prizes.
11. Picks entered cannot be changed or cancelled after the start time listed. It is the sole responsibility of the contestant to provide and maintain their contestant number and PIN.
12. Sponsor is not responsible for lost, interrupted, unavailable, defective or damaged hardware, software, and electronic, wireless, or telephone transmissions or technical failures, garbled transmissions, and the unavailability of its website or any website associated with Sports Contests. Due to the unpredictable nature of present, state-of-the-art computer technology, server outages may occur resulting in your inability to participate, receive point updates and point credits in a timely fashion. We regret this unfortunate possibility. By agreeing to the terms and conditions herein, you fully recognize that the Sponsor is not responsible for such errors.
13. The odds of winning depend on the number of participants and the number of points accumulated by each participant each week throughout the tournament.
14. Weekly winners will be notified by phone and e-mail and their names will be posted on on-site signage near the Meadowlands Player's Reward Club desk each Tuesday until the contest ends. The Grand Prize winner will be determined and notified by telephone and e-mail at the end of the contest.
15. PRIZES Basketball Sports challenge will run from March 15<sup>th</sup> through April 2<sup>th</sup> Weekly prizes: Week 1 (3/15-3/18/18) Dinner for two in Pink, Week 2 (3/23-3/25/18) \$100 betting voucher, Week 3(3/31-4/02/18) Dinner for two in Pink. Grand Prizes: Three Grand Prize winners: 1<sup>st</sup> place \$6,500, 2<sup>nd</sup> place \$2,500, 3<sup>rd</sup>place \$1,000. Prizes are given as betting voucher from the Sponsor.
